1. The Comité, with reference to its minute no. 11 of 19th September 2016, recalled that it had considered the driving licences online project (part of the eParishes work) and whether this should be delayed pending the VRS (vehicle registration system)/LICAR (driving licence system) review being undertaken by the Driver and Vehicle Standards Department (DVS).

The Comité received a paper from *teleologica* setting out work undertaken to date and the options to complete or to suspend the project; the timeline provided by eGov for the VRS/LICAR review and a paper setting out the roles and responsibilities of the Project Board and Project Team for that review. Following discussion, and having taken into account the advanced state of the driving licences online project, the Comité decided:

- a) To proceed with the online driving licences project for delivery in Q4 2016.
- b) That it should be represented by the Connétables of St Brélade and St Mary on the Project Board for the VRS/LICAR review and by parish officers on the Project Team.

(Jersey) Law

Approval of
Shooting Clubs

2. The Comité was informed that the Minister for Home Affairs had received an application from the Modern and Military Arms Association Limited for renewal of the approval as a shooting club under Article 15 of the Firearms (Jersey) Law 2000. Before granting or refusing to grant an approval or varying or withdrawing an approval, the Minister was required to consult the Comité in accordance with Article 15(3) of the law. The club had confirmed it could comply with the conditions which would be imposed should approval be granted and the Minister had indicated she was minded to approve the club as a shooting club but would not formally do so until she had received the Comité's views on the application. Having discussed the application the Comité agreed it had no comments to make and requested the Chairman to reply accordingly.
