Request

On 23 September 2020 a St Brelade's parish assembly was convened to consider the Hide Out mobile kiosk at La Pulente. My understanding is that the Assembly was convened under the Loi (1806) au Sujet des Assemblées Paroissiales. This requires the Constable or Rector to convene an Assembly within 14 days of a request from at least 10 Principals.

Can each Parish confirm whether they received requests for Assemblies under the Law in the last ten years stating:

- The parish
- The date of the assembly
- The subject to be considered

Response

Under Article 9 of the Loi (1804) au sujet des assemblées paroissiales a Parish Assembly is convened when requested by 10 or more principals of the Parish (the request must be made in writing, be dated, and mentions the subject for which the convening of the Assembly is sought).

No such Parish Assemblies have been requested in the last ten years for the following Parishes –
