# I write with reference to the above infractions allegedly committed by yourself on the 7 July 2023 at The states of Jersey Airport Car Registration number:-

You were seen and evidentially photographed parked, blocking the arrivals exit and entrance to the main carpark, contravention of the Aerodromes Law (J) 1965. This infraction incurs a financial penalty of £100

If you wish to dispute the infraction I would ask in the first instance that you call the Parish Hall and arrange a time and date to attend a Parish Hall Enquiry. If you admit the offence I would ask that you call the Parish Hall to settle the matter

## Circulation and parking of vehicles[7]

(1) The airport authority may from time to time issue such directions as the airport authority thinks fit regarding the circulation and parking of vehicles on any aerodrome, and may make such charges as the airport authority thinks fit for the use of any part of an aerodrome set aside for the parking of vehicles. [8]

(2) If any person contravenes any direction issued by the airport authority under this Regulation he or she shall be liable to a fine of level 2 on the standard scale. [9]

#### prohibited acts

No person shall on any aerodrome -

- (a) obstruct or interfere with the proper use of an aerodrome;
- (b) obstruct, impede, resist or assault any person in the execution of his or her duty in relation to an aerodrome;
- (c) remain on an aerodrome after having been required to leave it;
- (d) allow any vehicle or animal to be on an aerodrome after having been required to remove it or after its presence on an aerodrome has been forbidden;
- (e) allow any animal to stray onto an aerodrome or fail to keep any animal under control whilst on an aerodrome;
- (f) board or attempt to board any aircraft without the authority of the person in charge of it;
- (g) tamper or interfere with any aircraft or anything used in connection with an aircraft:
- (h) smoke in, or otherwise bring into or light any naked light in -
  - (i) any place where any such act is prohibited by notice, or
  - (ii) any place within 50 feet of an aircraft or a store of liquid fuel or explosives;
- (i) do any act which might cause or tend to cause an outbreak of fire;
- (j) throw or discharge any stone or missile;
- (k) climb any wall, fence, barrier, railing or post;
- (1) wilfully give a false fire or ambulance alarm;
- (m) drive or place a vehicle carelessly or dangerously or without due consideration for persons using the aerodrome;
- (n) fail to stop a vehicle when required by an official so to do;
- (o) park a vehicle elsewhere than in a place provided for that purpose or fail to pay any relevant charge for parking a vehicle in such a place;
- (p) fail to remove a vehicle from an aerodrome or from any parking place when required so to do;
- (q) wilfully and unreasonably interfere with the convenience of, or cause annoyance to, any other person;
- (r) behave in a manner reasonably likely to offend against public decency;
- (s) be in an intoxicated condition;
- (t) remove, displace, damage, deface or alter any marker, light, signal, or notice used in connection with an aerodrome;
- (u) throw down, deposit, put or leave, otherwise than in a receptacle provided for the purpose, any refuse of any nature whatsoever. [20]

#### **Penalties**

If any person contravenes any of the provisions of these Regulations, or any directions issued or given under these Regulations, in relation to which no special penalty is provided, he or she shall be guilty of an offence and shall be liable to a fine of level 3 on the standard scale. [26]

These Regulations may be cited as the Aerodromes (Jersey) Regulations 1965.

Joao and Maria should be able to sort this out it is important that if we are issuing infraction notices that they are issued legally.

We also discussed the issue at our last Treasury Ministerial meeting, and I have some concerns about the photo's being sent to the Parsih Hall.

The only evidence of the infraction is the photo, as your parking officer does not approach the motorist, nor does he hand the infraction notice to them.

I believe the photos are taken using an iPhone which creates several issues as to whether they are acceptable as evidence. In addition, there are GDPR concerns regarding the storage and deletion of these images, there are no sign warning the public that they may be photographed and finally the images sometimes include members of the b public who are not connected in any way to the Parking Infraction.

Before a motorist decides to take up the option of dealing with the matter at the Magistrates Court, which they are entitled to do, I think legal advice should be sought to ensure that the procedure involved meets the evidential requirements.

I don't have any issues with this document from the point of view that it sets out the law and the articles within it that relate to Parking at the Airport.

However, the Airport Authorities are missing the point.

It's not the Laws that are in question it is the method by which they collect the evidence or advise the public that there are Parking restrictions that are questionable.

A Parish Hall enquiry requires the same level of evidence as at the Magistrates Court – until they can produce a that the use of an iPhone for taking photographs of alleged infractions which confirmation often include 3rd parties who are not involved in any way with the infraction meets the threshold, we cannot process any Parking Notifications. In addition, we must be assured that the storage and transmission of these photographs meets all legal requirements including GDPR.

If you look at the process for a body worn camera to be used for evidence this falls far short of that.

This document does not cover the collection of the evidence and how that should be legally obtained - there is more work to be done.

Do I need to take this up with Ian Gorst for the third time?

Please find attached 3 photos of a Renault Clio, the driver of this vehicle was moved by myself from the drop only zone immediately before the bus stop outside arrivals today.

I walked away after he left there (I sent him to 30 mins free parking), I was then pulled up by a taxi driver complaining about a car parked on the road outside arrivals (1st two pics), it was the same car I'd moved on, he argued with me and I again sent him to long stay carpark, he drove away, 5 minutes later he again returned and parked on the road next to the carpark entrance (pic #3), again arguing with me, I again told him where and how to park but he again argued he had no way of paying, I again explained that parking was free in the long stay carpark for the 1st 30 minutes, he again drove off, he returned and finally did his passenger collection from the arrivals bus stop and left the airport, I wasn't able to speak to him at this time.

## Road safety highlighted at the Airport

Ports of Jersey is highlighting the road-safety measures in place at the airport to protect passengers while they are moving around the site. New signage has been erected to raise awareness of the regulations, which are intended to ensure the safety of everyone who uses the airport, especially pedestrians and cyclists.

In August 2023 the speed limit around the airport site was reduced from 20mph to 15mph. New Belisha beacon lights are being fitted to ensure motorists have clear visibility of the pedestrian crossings.

The area in front of Departures is only to be used when dropping off passengers, no waiting in this area is permitted and vehicles must not be left unattended.

Picking up or dropping off at the airport bus stop is not permitted and anyone doing so is liable to a fine of £100. It is illegal to wait in a bus stop throughout the island.

Libertybus Director, Kevin Hart, is concerned that motorists using the Airport bus stop as a dropoff or pick-up point are not only breaking the law, but also compromising the safety of bus passengers. He said: "We very often see cars picking up and dropping off on the bus stop at the Airport. This leaves our buses blocking the road and our customers having to walk into the road to board the bus.

"We encourage people to take the bus to and from the Airport and the safety of our customers is of the utmost importance to us, so we are firmly behind Ports of Jersey in reinforcing this safety message."

The airport's Head of Security, Maria Le Tiec, said: "We want to ensure the safety of all our passengers, so we have introduced new signage to highlight the existing road safety measures and ensure people can make their way safely from the car parks, bicycle parks and bus stops to the terminals.

"We hope this new signage will make people aware of the regulations, so that everyone can enjoy a safe and pleasant journey through the airport. These measures are in place to ensure our road network is secure for all."

#### Free parking

Anyone waiting for arriving passengers can use the Long Stay car park, which is free for the first 30 minutes and 90p per hour after that. The Arrivals car park costs £1 per half hour, please note the 30 minutes free does not apply in the arrivals carpark.

The area outside Departures is only for dropping passengers off, not for parking or picking passengers up.

There are designated parking spaces for disabled badge holders in both car parks and passengers with reduced mobility are welcome to book special assistance.

You can pay using a card or phone when exiting both car parks, so there is no need to use payment machines.

There is also a bicycle rack in the Car Rental parking area.

1. Purpose

1.1. The purpose of this Direction is to set out the Parking, Speed and Traffic Restrictions at Jersey Airport

2. Scope

2.1. The following parking, speed and traffic restrictions apply within the aerodrome areas administered by Ports of Jersey Limited.

3. Responsibilities

3.1. The oversight and enforcement of this Direction will be carried out by Ports of Jersey employees and third parties authorised by the Airport Director.

4. General Direction

4.1. This General Direction is issued in accordance with the Powers of Airport Director as set out in the Aerodromes (Jersey) Regulations 1965.

5. Parking

5.1. This direction sets out the General Provisions relating to Airport Parking Infractions in the table below.

Road Traffic (St. Peter) (Jersey) Order 1992 - Article 7: Restriction on parking (3)

- If any person contravenes any direction issued by the airport authority under the 5.4. Aerodromes (Jersey) Regulations 1965, they shall be liable to a fine of level 2 on the standard scale (as defined in the Criminal Justice (Standard Scale of Fines) (Jersey) Law 1993.

#### 6. **Speed Limits**

- Speed limits within the Aerodrome are as below: 6.1.
  - 6.1.1.15 miles per hour on all roads within the aerodrome area; and
  - 6.1.2.5 miles per hour within all aerodrome car parks.

#### **Window Displayed Insurance Discs** 7.

This direction sets out ability for Ports of Jersey employees and third parties authorised by 7.1. the Airport Director to check vehicles parked within the aerodrome areas to ensure they have a valid insurance disc displayed as required by the Motor Traffic (Third Party Insurance) (Jersey) Law 1948.

8. One-Way Traffic

8.1. All traffic accessing the Airport from the roundabout giving access to the Airport Road from L'Avenue de la Reine Elizabeth II and L'Avenue de la Commune is restricted to a one-way system as indicated.

#### 9. Ownership and Approval




