Request

I am writing to make a FOI request regarding the Residents' Parking Zone (RPZ) permits for the St. Mark's area of St. Helier (inc. Business permits).

This does not need to include previous FOI requests where responses have been made and are in the public domain. These are in (date order): 1) 18/10/2016, 2) 12/11/2019 and 3) 21/10/2020.

Please can you furnish the following information:

- 1. The number of permits issued and the number of spaces allocated for the zone in that yearly period (including Resident Only spaces and Paycard spaces) year-on-year from the inception of the scheme to the present day
- 2. The cost of the permit year-on-year from inception to the present day
- 3. The number of fixed penalty notices issued to RPZ permit holders distinguished by type of alleged offence year-on-year from inception to the present day
- 4. The number of residents on the waiting list for RPZ permits in the area year-on-year from inception to the present day
- 5. The number of spaces lost to parish requests for spaces to be coned off for essential maintenance/ other requirements and what cost recovery the parish received if any for these from inception to the present day.

Response

1. The Parish only holds the number of permits issued in the St Marks Zone from 2018 –

2. Information on the cost of the permit year-on-year from inception to the present day is exempt.

FOI exemption applied:

Article 23 - Information accessible to applicant by other means

Information is absolutely exempt information if it is reasonably available to the applicant, otherwise than under this Law, whether or not free of charge. A scheduled public authority that refuses an application for information on this ground must make reasonable efforts to inform the applicant where the applicant may obtain the information.

Justification for exemption

Since 1st November 2004, the Parish of St. Helier has been administering the RPZ and the permit cost is set in the Road Traffic Orders available on jerseylaw.je (GST not included in prices shown).

- 4. The Parish only holds a rolling waiting list, which currently shows there are 47 Residents and 2 business on the waiting list.
- 5. The Parish does not hold a record of this information.
