1. The minutes of the meeting held on 17th June 2024, having been previously circulated, were taken as read and were confirmed.

2. The Supervisory Committee, with reference to its minute no. 2 of 17th June 2024, in accordance with Article 11(1) of the Rates (Jersey) Law 2005, was invited to approve the Rates Lists for 2024 for Grouville and St Ouen. The Committee was informed that several appeals against the rateable value for land in Grouville had been received and had yet to be considered by the Rate Appeal Board, the Rates List must be signed in accordance with the Law on or before the last day of July and that Article 11(3) of the Law provided that, if a decision of the Rate Appeal Board was pending, the Committee might still approve a Rates List and amend it after it had been approved if the decision of the Board so required.

The Committee, having noted that all Connétables had had the opportunity to view the rateable values in each Parish as contained in the Rates Lists using the Rates Online service, then approved the Rates Lists for Grouville and St Ouen and three members of the Committee signed the form of declaration and certificate to be appended to each Approved Rates List certifying its approval as follows –
