## **Non-exempt (public) under Freedom of Information (Jersey) Law 2011**

- Minutes 1. The minutes of the meeting held on 12<sup>th</sup> July 2024, having been previously circulated, were taken as read and were confirmed.
- Rates Lists for 2024 – amendments following appeals 2. The Supervisory Committee, with reference to its minute no. 2 of 12<sup>th</sup> July 2024, noted the decisions of the Rate Appeal Board on appeals against rateable values and, in accordance with Article 11 of the Rates (Jersey) Law 2005, amended the Approved Rates List of the Parish of Grouville and, in accordance with Article 14(3) of the Law, asked the Parish to ensure the Rates List that was available for public inspection was amended accordingly.
- Rate Appeal Board report for 2024 3. The Supervisory Committee received the report of the Rate Appeal Board on appeals against 2024 rateable values. The Committee noted that of the fifteen appeal forms received in 2024 (relating to 14 properties), the Board maintained the assessments of nine properties and amended the assessments of five properties (minute no. 2 of this meeting refers). The report would be made available to the Chairmen of the Assessment Committees.
- The Committee noted that the terms of office of the Board's members would expire on 27<sup>th</sup> March 2025. Members were appointed by the States on the recommendation of the Minister for Treasury and Resources, in accordance with the Rates (Jersey) Law 2005, and the Minister would, in due course, lodge a proposition to appoint members.
- Office accounts and budget 4. The Supervisory Committee noted the draft unaudited accounts for the office for the year ended 30<sup>th</sup> April 2024 and that the audited accounts would be available at the next meeting. The Committee approved the budget for 2024/2025, covering staff and office costs, and agreed that each Parish would contribute £12,070 towards the estimated

expenditure of £149,380. The budget of £3,600 requested by the Comité des Chefs de Police was also approved and this would be shared equally (£300 per Parish).
