Request

I should be grateful if you could provide the following for each of the members of the current Roads Committee (Comite des Chemins) of the Parish of Trinity:

- 1. Current age
- 2. Date elected to current term of office
- 3. Dates of all previous terms of office held both:
 - 3.1. On the Roads Committee, and
 - 3.2. In any other honorary or paid positions as an official in the Parish of Trinity
- 4. Current occupation and previous occupation if different
- 5. Names of any immediate family members holding honorary or paid positions in the Parish of Trinity, together with the position and their relationship to the Roads Committee member.

Response

1. Current age

This information is not requested from applicants who stand for election at a Parish Assembly and to the extent the same is held for any individual would be exempt personal information under Article 25.

2. Date elected to current term of office

This information is already available and therefore exempt under Article 23. Please refer to Parish Assembly minutes for this information: <u>Parish Assembly 5.12.23</u>

- 3. Dates of all previous terms of office held both:
- 3.1. On the Roads Committee
 - Mr Fossey is in his seventh term of office on the Roads Committee (first elected in 2005);
 - Mr Dunford is in his fourth term of office on the Roads Committee (first elected 2014); and
 - Mr Le Maistre is in his second term of office on the Roads Committee (first elected 2020).
- 3.2. In any other honorary or paid positions as an official in the Parish of Trinity
- Honorary positions
 - Mr Fossey served as a Constable's Officer in Trinity's Honorary Police from 1967 1988. He also served as a Vingtenier from 1988 – 2003.
 - Mr Dunford served as a Constable's Officer in Trinity's Honorary Police from 1988-1991. He also served
 as a Centenier from 1991-2000.
 - Mr Le Maistre served as a Constable's Officer in Trinity's Honorary police from 1995-2000. He also served as a Vingtenier from 2000-2001 and a Centenier from 2001-2017.

- Paid positions

This information is not requested from applicants who stand for election at a Parish Assembly and to the extent the same is held for any individual would be exempt personal information under Article 25.

4. Current occupation and previous occupation if different

This information is not requested from applicants who stand for election at a Parish Assembly and to the extent the same is held for any individual would be exempt personal information under Article 25. Should reference have been made to a candidate's occupation by a proposer or seconder, and that information recorded in the Parish Assembly Minutes when the person was elected to office, the information would be absolutely exempt under Article 23. Parish Assembly minutes since 2019 are available online, Meeting Minutes Parish of Trinity; minutes of earlier meetings are available either at the Parish Hall or at Jersey Archive.

5. Names of any immediate family members holding honorary or paid positions in the Parish of Trinity, together with the position and their relationship to the Roads Committee member.

This information is not requested from applicants who stand for election at a Parish Assembly and the Loi (1914) sur la Voirie does not restrict candidates based on family relationships or employment by the Parish. Accordingly, to the extent this information is held for any individual, this constitutes exempt personal information under Article 25.

FOI exemptions applied:

Article 23 - Information accessible to applicant by other means

Information is absolutely exempt information if it is reasonably available to the applicant, otherwise than under this Law, whether or not free of charge. A scheduled public authority that refuses an application for information on this ground must make reasonable efforts to inform the applicant where the applicant may obtain the information.

Article 25(2) - Personal Information - Personal data, applicant not subject but supply contravenes data protection principles

Information is absolutely exempt information if - (a) it constitutes personal data of which the applicant is not the data subject as defined in the Data Protection (Jersey) Law 2018; and (b) its supply to a member of the public would contravene any of the data protection principles, as defined in that Law.
