- (i) anything in respect of planning (including proposals, even if these were ultimately not pursued);
- (ii) any discussions with or applications made to the Roads Committee; and
- (iii) any updates to the rates list?

- 2) In relation to land at St Peter, Jersey comprising:

- i. Field 626 (also known as Le Clos des Mielles); and
- ii. Field 627 and 627 A (also known as Les Longs Champs du Nord, Les Longs Champs des Mileu and Les Longs Champs du Sud),

together the "St Peter Agricultural Site" also sold by Penventon Limited to Eastleigh on 19 January 2024, can you please provide any information or records for the period from 1 January 2022 to 31 December 2024 including (but not limited to):

- (i) anything in respect of planning (including proposals, even if these were ultimately not pursued);
- (ii) any discussions with or applications made to the Roads Committee; and
- (iii) any updates to the rates list?

#### FOI exemptions applied:

##### Article 23 - Information accessible to applicant by other means

Information is absolutely exempt information if it is reasonably available to the applicant, otherwise than under this Law, whether or not free of charge. A scheduled public authority that refuses an application for information on this ground must make reasonable efforts to inform the applicant where the applicant may obtain the information.

##### Article 25(2) - Personal Information - Personal data, applicant not subject but supply contravenes data protection principles

Information is absolutely exempt information if – (a) it constitutes personal data of which the applicant is not the data subject as defined in the Data Protection (Jersey) Law 2018; and (b) its supply to a member of the public would contravene any of the data protection principles, as defined in that Law.

##### Article 26 - Information supplied in confidence

Information is absolutely exempt information if –

- (a) it was obtained by the scheduled public authority from another person (including another public authority); and
- (b) the disclosure of the information to the public by the scheduled public authority holding it would constitute a breach of confidence actionable by that or any other person.

##### Article 33 – Commercial Interests

Information is qualified exempt information if –

- (a) it constitutes a trade secret; or
- (b) its disclosure would, or would be likely to, prejudice the commercial interests of a person (including the scheduled public authority holding the information).

## Prejudice Test

The scheduled public authority (SPA) has considered whether disclosing information would lead to prejudice.

On balance, it is deemed that release of certain information would be likely to be prejudicial to the Parish by undermining the extent to which future parties might be willing to discuss future proposals at an early stage where they had asked it to be kept confidential.

As this exemption has been engaged, it is then necessary to consider the balance of public interest.

## Public Interest Test

A SPA must supply qualified exempt information if it has been requested to supply unless it is satisfied that, in all the circumstances of the case, the public interest in supplying the information is outweighed by the public interest in not doing so. Article 9(2) requires the SPA to consider whether "in all the circumstances of the case", the public interest in maintaining the exemption outweighs the public interest in disclosure.

Amongst other matters, it was noted that there is a need for SPAs to have transparency, accountability, financial and good decision making, in order to facilitate understanding and public debate and the Law is intended to enable the release of information unless there is good reason this should not occur. However, there is also an inherent need to avoid prejudice being caused to third parties and SPAs.

On balance, it is judged that the public interest of disclosing the information requested is outweighed by the public interest in maintaining the exemption.

Dear Chief Minister

I met with Connetable of St Peters yesterday afternoon to give him an update on the progress of our application P/2024/0413 for 42 homes on fields P655/656

In general, the application is progressing well and we are in expectation of a Committee hearing on the 27<sup>th</sup> September.

The Connetable mentioned he made you aware that large Infrastructure drainage costs are putting the delivery of the scheme in jeopardy.

Figures have been mentioned ... to install public upgrading drainage infrastructure, something that the viability of an affordable housing scheme cannot accommodate

We have preliminary agreement, subject to planning permission, to sell the completed units to Andium, we are planning to commence development, if we are successful, in January, completion late 2026.

We are committing to significant Highway improvements & infrastructure in the village ... and we have budgeted to pay for the local drainage infrastructure from the site to the first available public manhole, ;

Another concern is that if the issue of the infrastructure costs are not resolved prior to the planning meeting later in the month, the Planning Committee are likely to refuse or defer the decision until there is clarity on the timescale & costs of the public drainage infrastructure.

In discussion with the Connetable, whom I have copied in, he advised that I should contact you without delay and see if matters can be dealt with prior to the Planning meeting.

We are happy to meet up and discuss this further,

We are very aware that the Parish has an ageing population, and this new development is essential both to meet the current demand for family homes and for the future survival of our village infrastructure.
