### **Minutes**

1. The minutes of the meeting held on 16<sup>th</sup> June 2025, having been previously circulated, were taken as read and were confirmed.

### **Approval of Rates Lists for 2025**

2. The Supervisory Committee, with reference to its minute no. 2 of 16<sup>th</sup> June 2025, having noted the decisions on appeal and in accordance with Article 11(1) of the Rates (Jersey) Law 2005, approved the Rates Lists for 2025 for the following Parishes. The Committee noted that all Connétables had had the opportunity to view the rateable values in each Parish, as contained in the Rates Lists, using the Rates Online service. Three members of the Supervisory Committee signed the form of declaration and certificate to be appended to each Approved Rates List certifying its approval as follows –
